Privacy and data protection

Pursuant to Article 23 of the Law on Personal Data Protection ("Official Gazette of the RS", No. 87/2018 - hereinafter: the Law), provides the user with the following information at the time of data collection:

Personal data: OKS is committed to protecting the privacy of mobile application users.

By entering their personal data into the application, users agree to the processing of personal data in accordance with the privacy and data protection policy regulated by these Terms. Personal data processed by OKS consists of data provided directly by users and data provided indirectly by users.

The data that users submit directly are: credentials for logging in to the mobile application (email address and password or Open ID from providers Google, Facebook or Apple), name, surname, photo, year of birth (to verify the minimum age for using the application), gender, height, weight, BMI, city and country, current user location, pace (min / km), distance traveled (km), calories, duration of activity (min), running speed (kph), number of steps, elevation during running (m), heart rate (bpm), trajectory while moving, consent to receive emails or SMS messages about news, events or news of OKS, consent to the processing of personal data and consent to the <u>General Terms of Use of the TreninGO application</u>.

After installing the mobile application, the user is shown the General Terms of Use of the application during the process of creating a user account. It is necessary that the user reads, understands and agrees with the General Terms and Conditions, as well as, before using the application, if he agrees, to give his consent by ticking the provided field, as well as to give his consent to the processing of personal data. application.

The processing of user data for the functionality of the application itself is done on the basis of consent. The legal basis for data processing is the contractual relationship between the user and OKS for the use of the TreninGO application.

Data provided by users indirectly: Analytical data on the use of the application that are collected for the purpose of analysis and optimization of the use of the application and user experience; Application and device information such as user IP address, user device ID, user device operating system version, and the like, stored on the device and used by users through the application to access services.

Geolocation data (user location data) is not stored, except as part of running statistics, to show the user the run track. Google Maps provides information about the nearest outdoor gym or treadmill location, as well as the user's current location, only if the user has turned on the location tracking option on their mobile device.

After selecting the desired outdoor gym or treadmill, the app can offer the user navigation to its location using third-party apps that the user has installed on their phone.

Purpose and justified reasons for processing personal data

Purpose and basis for processing personal data:

- Providing TreninGO mobile application services in accordance with the End User License Agreement ("EULA"), as well as for managing the process of possible complaints of application users,
- Ensuring the security of services provided through the application, in order to ensure their proper use, to prevent misuse of the application and services from the application as well as to identify and / or investigate fraudulent activities,
- To share user data with third parties when necessary, which may occur in the following cases:
- When using the option of registering a user account via the Open ID of the provider Google, Facebook or Apple, in which case OKS may use the data (name, surname, email and profile photo) obtained by the provider Open ID in accordance with the privacy policy of that provider ;
- In the event of a change in ownership of the application, in which case the user must be notified that their personal data has been transferred to the new owner. In case of change of ownership over the application, he can decide whether he

wants to continue using the services of the application, while the new data controller is obliged to undertake all legally prescribed obligations.

Data retention time / revocation of consent for data processing

OKS undertakes to keep all personal data of the user during the entire period of existence of the user account.

The user can revoke the consent at any time. When revoking the consent for data processing, the user is informed that OKS has the right to stop providing the service through the application. If the user revokes the consent for data processing, the data will be anonymized. The user can withdraw consent through the application by irrevocably deleting his account, or by sending an email to treningo@oks.org.rs.

User rights based on personal data protection

The user has the right to:

- To request from the controller in accordance with Article 26 of the Law access to data, the right to correct and supplement data or delete personal data of users in accordance with Articles 29 and 30 of the Law, the right to limit processing in accordance with Article 31 of the Law, the right the portability of data in accordance with Article 36 of the Law, as well as the right to object in accordance with Article 37 of the Law;
- To revoke consent at any time, provided that the revocation of consent does not affect the admissibility of processing on the basis of consent before revocation, if the processing is performed on the basis of the person's consent to the processing of his / her personal data for one or more specific purposes; to which the data refer for processing for one or more purposes of processing, unless the law prescribes that the processing is not performed on the basis of consent;
- To submit a complaint to the Commissioner for Information of Public Importance and Personal Data Protection in accordance with Article 82 of the Law, if he / she considers that the processing of the User's personal data has been performed contrary to the provisions of the Law;

Data and information protection

OKS uses administrative, technical, organizational and physical protection measures in order to protect personal data. Measures include traffic control, infrastructure protection, cryptographic protection, firewalls, access rights systems and the like.

OKS makes efforts to constantly maintain and improve security, and in that sense regularly controls the information protection systems and the operation of the application. If, despite all the measures taken, data security is compromised, users will be notified immediately and all measures will be taken to reduce the negative effect.

All data on the mobile device in the application concerning the user account and personal data are stored only in encrypted format.

Deleting a user account, whether it is an account created using credentials (email addresses and passwords) or using an Open ID provider (Google, Facebook or Apple), is done by selecting the option "Delete account" within the application profile, which selects the user deletes all data which he entered into the application. Thus, the previously active account ceases to exist, and no personal data that may indicate a link to the user account is retained in the OKS system. The user can also send a request to delete his account by sending an email to treningo@oks.org.rs. For security reasons, it is necessary that the email message be sent from the e-mail address with which the account was created.

Additional terms on using the application

The user undertakes to refrain from any action that could be classified as intentional abuse and fraud and undertakes not to use or attempt to use someone else's user account and / or access other people's personal data.

The user agrees not to use reverse engineering, reassembly, disassembly, decoding or any other means to discover the source code of the application or any related technology.

The user guarantees the accuracy of the personal data provided directly. The use of the application is allowed to persons who have reached the age of 6 or more.
